### 1901 **TITHOLES ORCHARD**

The Chairman reported with the Clerk she had met with Eric Beaven to go through the lease document to compare the original changes against the alterations MHPF were willing to accept. She advised that MHPF had accepted removal of all references to The Crown, amendment to onerous insurance provisions and removal of renewal provision on the access road. Councillors were happy in particular to see that the two major risks to the Parish Council, i.e the insurance and the access road renewal had been agreed to be changed. It was agreed by all that the latest amended version of the draft lease was acceptable to the Parish Council. Councillors agreed that as a final check and to follow due process that the amended lease be checked by a Solicitor and that Risdons Hosegood be instructed to carry out this work as they had acted previously for the Parish Council. The Chairman would instruct Eric Beaven to liase with Risdon Hosegood.

It was requested that all emails relating to Titholes be circulated to all Councillors.
